

RACIAL & RELIGIOUS TOLERATION ACT 2001

Victoria's new Racial and Religious Toleration Act came into force on 1ST January 2002. The main purpose of the Act is to make conduct that, on the grounds of race or religion, stirs up hatred of another person or groups of persons an offence under the law of Victoria. ICV encourages Islamic societies in Victoria to support the information and education campaign that has now been launched to inform all citizens of their new rights and responsibilities under the legislation.

Editorial

The three wise men or the dogs of war: Bush, Blair and Howard? The self appointed dream team against the socalled 'axis of evil'. When millions of people all over the world have expressed their vehement opposition to any military operation against the people of Iraq the leaders of the USA, UK and Australia are hell bent on unleashing the deadliest weapons and bombs on Iraq. Why? Is it for the love of the people of Iraq or for some self centred selfish Anglo American policy? The reasons are pretty obvious.

The three wise men say that an attack is necessary so as to eradicate the weapons of mass destruction. With what do they want to eradicate those weapons? Eradicate with the mother of all bombs -(MOAB). Isn't the MOAB a weapon of mass destruction? Time to inspect the weapons of the USA.

USMAA JANAZA PROCESS

Procedures to be followed in the case of death (updated 2002)

Please note and retain information preferably with a copy in your car and near your telephone.

Strict adherence to the different procedures is requested to alleviate any unnecessary delay and trauma to all concerned.

If death has occurred at home, please follow all procedures mentioned below:

- Inform your family doctor or • doctor who has been treating the deceased person prior to death.
- Call 000 Emergency and request for ambulance.
- Once the doctor has examined the deceased, either at home or hospital, request a full certification of death.

Full certification is of utmost importance - if any autopsy is to be avoided and also before an Islamic undertaker can be notified.

NOTE: the doctor, ambulance officer or police, depending on the cause of death, may only authorise removal of the deceased to the coroner's complex for the following reasons:

- a) The deceased has undergone a surgical procedure i.e. operation preceding death.
- b) Death caused by an accident.
- Suspected foul-play. c)
- In most instances the authorities referred to above will assist in informing the coroners office for removal of the deceased from either home or hospital (Coroners South Melbourne Complex Tele: 9684 4444).
- Further it is important that at all times, the USMAA Janaza Committee be kept informed. Although no guarantee can be given, the committee will endeavour to avert a post-mortemautopsy from being performed on the deceased by liasing with the authorities concerned.

Nose: indicates intelligence

Two front paws: purity in handling wealth

Orange Stripe: Tamil race

Green Stripe: Muslim race

Yellow border round the flag: represents the other minor races, including the burgher community

Bo-leaves at the four corners: represents Buddhism and its influence on the nation. They also stand for the four virtues of kindness, friendliness, happiness and equanimity

Maroon colour – manifests the other minor religions

Government to study Supreme Court ruling before action - PM

Prime Minister Ranil Wickremesinghe declared that the Government intends making a full study of the Supreme Court determinations on the 18th and 19th Amendments to the Constitution before coming to a decision on its next course of action.

According to the Speaker's ruling, the Court has shown an alternative way to implement the 19th Amendment. The Supreme Court has indicated that if the period for dissolution of Parliament is extended to three years, it could pass with a two-thirds majority in Parliament. Similarly, if the right of conscience vote applies to all clauses, the Amendment could be passed with a two-thirds majority.

Accordingly, the Supreme Court has not rejected in toto the proposed 18th and 19th Amendment Bills and has shown a way to present and pass them before Parliament without contravening the Constitutional provisions

83,000 Displaced People Resettled

Around 183,000 Internally Displaced People (IDP) have returned to their native places after the Ceasefire Agreement was signed in February this year, the United Nations Inter-Agency IDP Working Group said.

The majority of these IDPs have relocated in Jaffna, one of the most war-affected areas in the country. According to the latest estimates, 94,312 IDPs have returned to Jaffna while Kilinochchi, Mullaitivu, Vavuniya and Trincomalee districts have also received a large number IDPs from January to August. Among the returners are 45,812 families. With the growing number of settlers it has become an uphill task for the Government and the United Nations to provide them with a safe and conducive environment

Lanka-Pakistan Free Trade Agreement

Lanka-Pakistan Free Trade Agreement (FTA) to enhance FDI potential The signing of the Free Trade FTA) with Pakistan is expected to considerably enhance the potential of Foreign Direct Investment (FDI) into the country, a Board of Investment (BOI) official said.

This landmark event will take place this week when the Pakistani Minister of Trade Razak Abdul Dawood will arrive in Colombo at the head of a high-powered government delegation. The Board of Investment of Sri Lanka (BOI) is confident that the signing of this historical document will contribute to greater FDI into Sri Lanka both from Pakistan and from countries keen to export to that country.

The FTA will result in an expansion of the trade in goods and services, the creation of fair conditions for competition and the removal of

barriers which will in turn lead to an expansion of bilateral economic exchanges.
